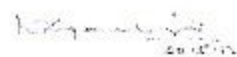

The Departmental Promotion Committee constituted by Govt. by its order fifth read above, has met on 31.07.2006 and approved the names of eligible Junior Lecturers for promotion (Recruitment by transfer) as Lecturers of Govt. Degree colleges. Consequently, the Junior Lecturers whose names are shown in the Annexure to these proceedings are temporarily appointed under Rule 10 (a) of the A.P. State and Subordinate Service Rules of 1996 as Lecturers in Commerce and posted to the colleges mentioned against their names.

It is informed that as per the Government orders issued in the reference fourth read above, the Junior Lecturers appointed prior to 1.1.1986 and promoted as Lecturers at any time after issue of G.O.Ms.No.61, Edn., dated 16.7.2001, shall be deemed to have been exempted from passing NET/SLET and from possessing 55% of marks in P.G. Degree to become eligible for U.G.C. Pay Scales. Further, the Junior Lecturers appointed after 1.1.1986 and promoted now, as Lecturers have to pass NET/SLET and possess 55% of marks in P.G. Degree to become eligible for UGC pay scales of 1996. However, they are eligible for State revised pay scales in the cadre of Lecturers.

The Junior Lecturers now promoted are informed that their services as Lecturer are liable to be terminated at any time without notice and without assigning any reason what so ever for such termination. They are also informed that their appointment as Lecturer is ordered without prejudice to the claims of other senior lecturers if any, in the subject in the zone.

The Junior Lecturers under orders of appointment as Lecturers to Government Degree Colleges are informed that they should join duty at the place of posting within 15 days from the date of receipt of these orders without fail as per the Government orders issued in the reference third read above, failing which they will forfeit their right for promotion for the present and future also.

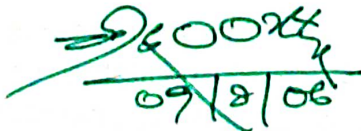

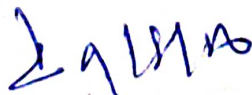
